During the financial Year 2014 -15 the organisation in Partnership with SMILE foundation started the project on educational Awareness for mainstreaming of the marginalized children in formal education system in three Slums of Patna in Bihar. Partnership with National Urban Health Mission, Govt. of India started the Urban Primary Health Centre of the Urban Poor & Slum Vasti in Patna Municipal, & Letzchang Foundation in Dalit Awareness Education Program

at Digha, Patna in January 1, 2015 under National Urban Health Mission, Govt. Of India, courtesy by the Health Committee of the State Government of Bihar. The center was launched by the Honorable Minister State SC Commission Mr. Bidyanand Bikl. on the occasion representative of Plan India of Bihar Shri Vishwaranjan was present and shared the objectives of National urban health mission. He also showed the the roadmap of the programme. In addition to that he shared that the clinic will open a new prospect for the slum dwellers with free health care with preventive and curative support. The area people like underprivileged slum dwellers, rikswa puller, vegetable vendors, daily labours and other who are not able to get the health services can get free health check up. The NUHM will meet health needs of the urban poor, particularly the slum dwellers by making available to them essential primary health care services.

The center will provide immunization support as well as the family planning awareness for the poor slum dwellers for the area. Mr. Bidyanand Bikl in his speech shared that to make the urban primary health center as Model health center the government will take all possible support. He also appreciated the work of the institution and praised to be

awarded for such outstanding work of the matter. Then Mr. Bidyanand Bikl inaugurated by doing health check up by Dr. Nishat Ahmad

On this occasion Sanjay Ram- Mahadalit commission member, Pankaj Swetang- Action Aid, Mr Bhushan Priya, Satish Kumar Sinha – Casa were also present.

#### State -level seminar

A State level seminar was Jointly organized by Dalit Vikas Abhiyan Samiti and on Poor, non-poor and the role of government Collective efforts for inclusive cities prgramme in Patna SCADA Business Center Ave. In that programme, the chief guest, **Mr. Samrat Choudhury, Honourable Minister, Bihar Municipal Housing Ministry,** shared that the

slums are very important. While discussing on backward slums and the Govt. master plan he shared that the inhabitants of Jhungi Jhupri are mostly from the Villages. They are landless, poor, evicted. But Govt. has prosperous plan for them like Development



Programme and urban SGSY. Under these plan the underprivileged people will be given skill development training and linked with sustainable income for livelihood. For their place of living, plan has been submitted to the Govt of India. The Rajiv Awas Yojana (RAY)has been planned which is an Indian government program that attempts to help slum dwellers gain appropriate housing and address the processes by which slums are created and reproduced. It was introduced by the Indian government's Ministry of Housing and urban poverty Alleviation. Survey has been done under Rajiv Awas Yojana for the selection of the homeless people. Poverty eradication programme also has been introduced for poverty analysis. In that porgramme, Non Govt. agencies do have a vital role for analysis the gaps between privileged and underprivileged families. Mr. manoj Roy, Director, PRIYA, Mr. Biwaranjan from Plan India, Mr. Mr. Samrat Choudhury, Honourable Minister, Bihar Municipal Housing Ministry and director of Dalit vikas Avhiyan Samiti were present.

• International Women Day: International Women day was celebrated by the organization as an event to motivate all CBOs, stakeholders to address the issues related

with women rights, violence and to promote their socio- economic right and leadership in the society. On the eve of the women's the organization organized a debate on the theme 'Women empowerment: opportunities and challenges'.

On the International women Day Dalit Vikas Abhiyan Samiti has organized a minded forum in Tejpur under samastipur district. In this forum women cadres showed solidarity and shared their views on violence against them and insist others to cope with feudal elements. In addition to that the issues like domestic violence, child rights, women rights were on discussion. To raise women voice some actions are taken like to empower and activate the Ambedkar Gram Samity, where it emphasizes to reach all women in the villages. In additional to that education of children also played an important role to mainstream drop outs or never been to school to develop the society. A total of 75 women cadres joined in that programme.

Women Empowerment Program: The social structure in the state of Bihar has been feudal and conservative. The basic human rights and the fundamental rights, assured by the Indian Constitution for women is distant mirage. Gender discrimination has continued to perpetuate violence against women and their subjugation continues at household, community and institutional levels. In all excluded and marginalized communities in the country, women are 'doubly' marginalized and burdened. Dalit, tribal and minority women face daily exploitation. They have been denied of their right to survival, protection and participation. On daily basis they face violence in various forms and intensities adversely impacting the sense of Self Dignity and physical and mental health. Dalit Vikas Abhiyan Samiti has been actively addressing the issues related with women since its inception. The current year witnessed following intervention by the organization to promote women empowerment as:

#### **COMPUTER TRAINING PROGRAMMES**

- Dalit Vikas Abhiyan Samity has planned to start free computer training to Dalit and MahaDalit children in the register office premises in Ramchandra Nagar. The objective of the programme is to provide computer knowledge for to provide skill development training to the youths for their self employment. Training on basic computer operation was provided among rural youths to orient them with the basic operations related with computers in a bid to enable them in use of new age technology. The participants were provided training on both theoretical and practical use of computers under the course. In all 50 youths were provided training on computers during the year.
- Adolescent Reproductive and Sexual Health: Health is one of the critical issues of the
  adolescent group as they reach puberty and in the next stage of their life i.e adult hood.
  At times several misconceptions and ignorance about change in their bodies become a
  subject of curiosity and even adversely impact their health.. To address the concern of
  the adolescent DVAS organized training on Adolescent Reproductive and sexual health
  among adolescent to orient them on the aspects of adolescences so that they meet the

physical growth with confidence. Inputs were provided on issues as menstrual cycle, Contraceptives and availability of Reproductive health services. The training also covered issues as spacing between two consecutive children and the average age for safe pregnancy. Information dissemination was carried out on the issues of pre natal health care and anti natal health care so that the adolescent take the needful precautions and reflect a more safe and matured sexual behavior.

#### **DOMESTIC VIOLANCE**

• Support to Dalit victims of Atrocities: In continuation of the its unabated efforts to address the issues of atrocity against the SC community and to support them in getting due justice DVAS along with its cadre force organised a awareness generation campaign to sensitize the larger communities on how to defend themselves in case of atrocities and to report the incidences with the concerned departments and mechanism for due justice. As a part of the initiative to promote justice to the victims the organisation intervened in several cases of murder, incidences of rape, physical torture and not only provided para leagal support but also pursued the cases with state and national scheduled caste commission for provision of compensation and punishment as per provisions of the law. Several victims of atrocities got relief from the activity:

#### City Level Symposium on the Educational Status Analysis of Urban Poor Children.

City Level Symposium on the Educational Status Analysis of Urban Poor Children has been organized by Dalit Vikas Abhiyan Samiti , Deep and PRIYA in auditorium of Bihar industries Association.

Mr. Dharmendar Kumar, director, Dalit Vikas Abhiyan Samiti facilitated the programme . The State Coordinator, Mr. Amitav Bhusan, PRIYA presented a study report on



the educational status, Literacy rate and the education of slum children, where it has been observed that 95 % of the urban slum children are out of school and they are engaged in rag picking , and at the same time mal nourished as well. They do not have the children friendly environment s well. Lack of school facilities in their nearby areas, alcoholism during rag picking, and the infectious diseases are the obstacles for them. The motivation and awareness towards education is required. Addressing the seminar , the Patna district education officer Mahesh Prasad , district program officer , block education officer shared that children should be mainstreamed for continuing their education. It is agreed that the education of the slum children is very challenging work as it is not a sustainable place. And that caused the irregularity within schools. The drop outs are increasing day by day. There are acts like Right to education and other. But we should move forward to address such issues, says, the delegates like slum development committee representative. There are 50 participants from different development sectors in the programme.

#### Special honour to Mahadalit literate women

On 24 November 2014 Dalit Vikas Abhiyan Samiti organized Adult literacy Drive programme for the of 15-35 age underprivileged and minority women population at Fatua Mahadalit area. Mr Dharmendra Kumar awarded those women who passed Basic Mahapricsha Under Free education Bihar Bidyalaya board.



Under this plan Dalit Vikas Abhiyan samiti is able to literate 2250 by women in their working areas

#### Establishment and Running of NFE Centres:

Three Non-Formal Education centre was run by the organisation to address the educational needs of the marginalized children of the slum with focus on children from Scheduled Caste and Maha Dalit Category. The Non formal Education centre provide them education free of cost based on the course content adopted on the basis of Bihar board Syllabus so that the students get the



educational inputs similar to that followed in the Government school. Apart from the class room teaching the students are also provided inputs on moral science, health and environment. The organisation has promoted extensive use of Teaching and learning material and sumer camps have also been organised.


#### • Activity: Parent Teacher meetings

Parent Teacher meeting was conducted on monthly basis as a regular activity to promote association and ownership of the parents in the management and developments at the educational centre. The meetings facilitated discussions on regular attendance of children to the NFE Centre and also on possibilities to change the nutrition in context to the change in situation.



#### Nukked Natak for Awareness on Nutrition and Education:

Nukked Natak (Street Plays) was organized by the children's enrolled at Non Formal Education Centre of Kankarbagh Slum and Digha of Patna to Educate the marginalized community on the Importance of Education and nutrition and its posies impact on health , personality development and life;

Wash Awareness Programmes in Ramchandra nagar Village of Fatuha Block in Patna District. The Programmes witnessed Participants Mr. Dilip Kumar Singh, Regional Demonstrative Officer, Ministry of Women & Child Development Department. Govt. Patna and Mr. Pinaki Ranjan Das Senior Program Officer, Smile Foundation; Who addressed



the marginalized Communities and Provided valuable information's on issues as health of women and their capacities for promoting leadership and education among the communities, personal and community sanitation, importance of Toilets, Health status of children etc. About 125 Community members participated in the Awareness Programme'

#### • Organizing Child Health Awareness Camps:

Three health checks -up programme was organized during the year for screeninghealth status of the Slum Children and suggesting them for follow up actions as per requirement. The health checkups focused on Season and congenital disease or any other

form of morbidity among the children. The health check was done by medical practioneer with support from paramedical team. The children were mostly affected by skin disease, worm infection, malnutrition and seasonal fever and infections etc. Few cases were counselled to visit government health infrastructure for follow up treatment and medicines.



The Health Checkups camp was organized at educational centre Ramchander Nagar. Dr. Manjeet Ranjan , Child Specialist of Tripolia Hospital , Patna and Dr. Sanjay Suman , Pathology and also at LohiyaNagar Slum of Patna carried out health screening of 225 children's. Some free medicines were also distributed among the children. It was observed that there are issues of malnutrition, ear eye and skin infections are common ailments among the children. With Anthers Programmes A health Checkup camp was organized on 22<sup>nd</sup> August at Lohiya Nagar Slum of Kankarbagh in Patna. The health camp provided medical screening services to 125 children and the health conditions of the children were diagnosed by Dr. Arjun Ram , MBBS , Gen Physician who also counseled the parents on the issues of nutrition and Hygiene. The children were generally found in good state of physical and mental health baring incidences of few ailments as cold, fever, Diarrhoa an skin infections. The parents were advised to make follow up with government health institutes for routing check up and medical services.

The issue related with educational exclusion of the children was discussed and a stock of the existing situation in the Parsa Panchayat on promotion of primary education was discussed and shared with the participants. The children stressed their demand that district education department



should take necessary steps to ensure that RTE is established in the block and the district as well. Education of girl child was felt to be the most urgently required for addressing the human rights of the dalit women.

• Bal Panchayat: A Bal Panchayat election was conducted in the education center of RamchanderNagar. The key objective of the Bal Panchayat was to nurture the sense of active citizenship and governance at the



bottom level. The elections were conducted for the post of Mukhiya, Upmukhiya and Sarpanch. Master Jyoti Kumar as Mukhiya , Master . Dhirajas Up Mukhiya and Master Sonu was elected as Sarpanch.

• Advocacy For establishment of Child Right: A candle March was taken out by the

children of Lohiyanagar and MalahiPakri Slum to raise their voice on violation of childright and non access to the provisions for children under the state and national provisions. THe candle march was taken from KargilChowk to District magistrate Secretariat and a memorandum of demands was given the district magistrate on ensuring Right to education, Right to Food, etc.



#### **Training organized for Slum Development Committee members**

The programme was all about the empowerment of total 50 slums and its inhabitance situated in Bodhgaya and jungijhopri.
